This information can include: Social Security Number and Income account balances and payment history credit history and credit scores When you are no longer our customer, we continue to share your information as described in this notice.

How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Tucumcari Federal Savings & Loan Association chooses to share; and whether you can limit this sharing.
